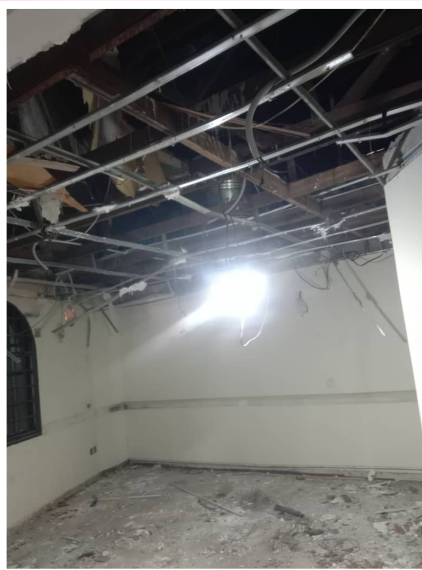
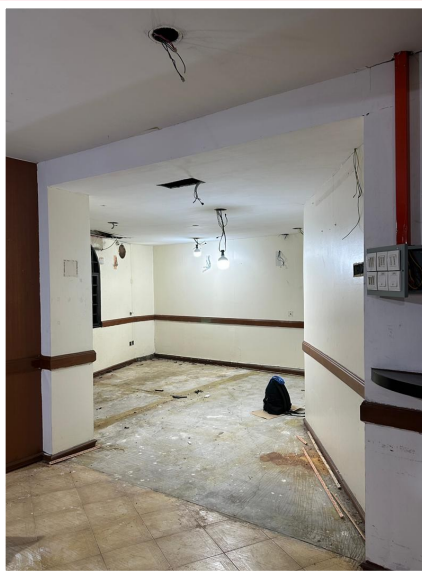

MEMBERSHIP

PROMOTION INCENTIVE PLAN

To encourage more applicants to join as Ordinary Members, the Club has introduced an incentive plan exclusively for Ordinary Members. Under this plan, existing members who successfully **recommend a candidate for Ordinary Membership** will be rewarded with a **RM500 F&B voucher**. This voucher will be valid for six months from the date of issuance and will only be issued after the candidate has made full payment for the Membership.

1. SENIOR MEMBER – TRANSFER OF MEMBERSHIP TO CHILDREN (APPLICABLE ONLY TO MALES)

A Senior Member may transfer his membership to his lawful son. The fees payable to the Club are as follows:

- Upon approval of the membership application, a Transfer Administration Fee of RM100 and a Refundable Deposit of RM2,500 will be charged for the transfer of membership.
- The member shall pay a monthly subscription of RM70.

2. SENIOR MEMBER BECOMING A PRIVILEGED MEMBER

- Upon the approved transfer of membership taking effect, the Senior Member may apply to become a Privileged Member under his son's membership.
- A monthly fee of RM40 will be charged and deducted from the son's account.
- This privilege is applicable only to the member and not to the spouse.
- All provisions of Rule 20A shall apply.

MEMBERSHIP

MEMBERSHIP INSTALLMENT PLAN

The Club has introduced a Membership Installment Plan to encourage new memberships, particularly for those who may find it difficult to pay the full membership fee in a lump sum.

Under this scheme, the total membership fee of RM14,920 may be paid via monthly installments of RM1,000, to be settled within 14 months from the date the application is approved. Members are encouraged to make payment within the first week of each month and may opt to pay a higher amount or settle the balance earlier if convenient.

Please note that failure to make payments for four (4) consecutive months may result in termination of membership at the discretion of the General Committee. Additionally, the credit limit under this scheme will be capped at RM1,000 and will only be increased to RM2,500 upon completion of six (6) months of installment payments.

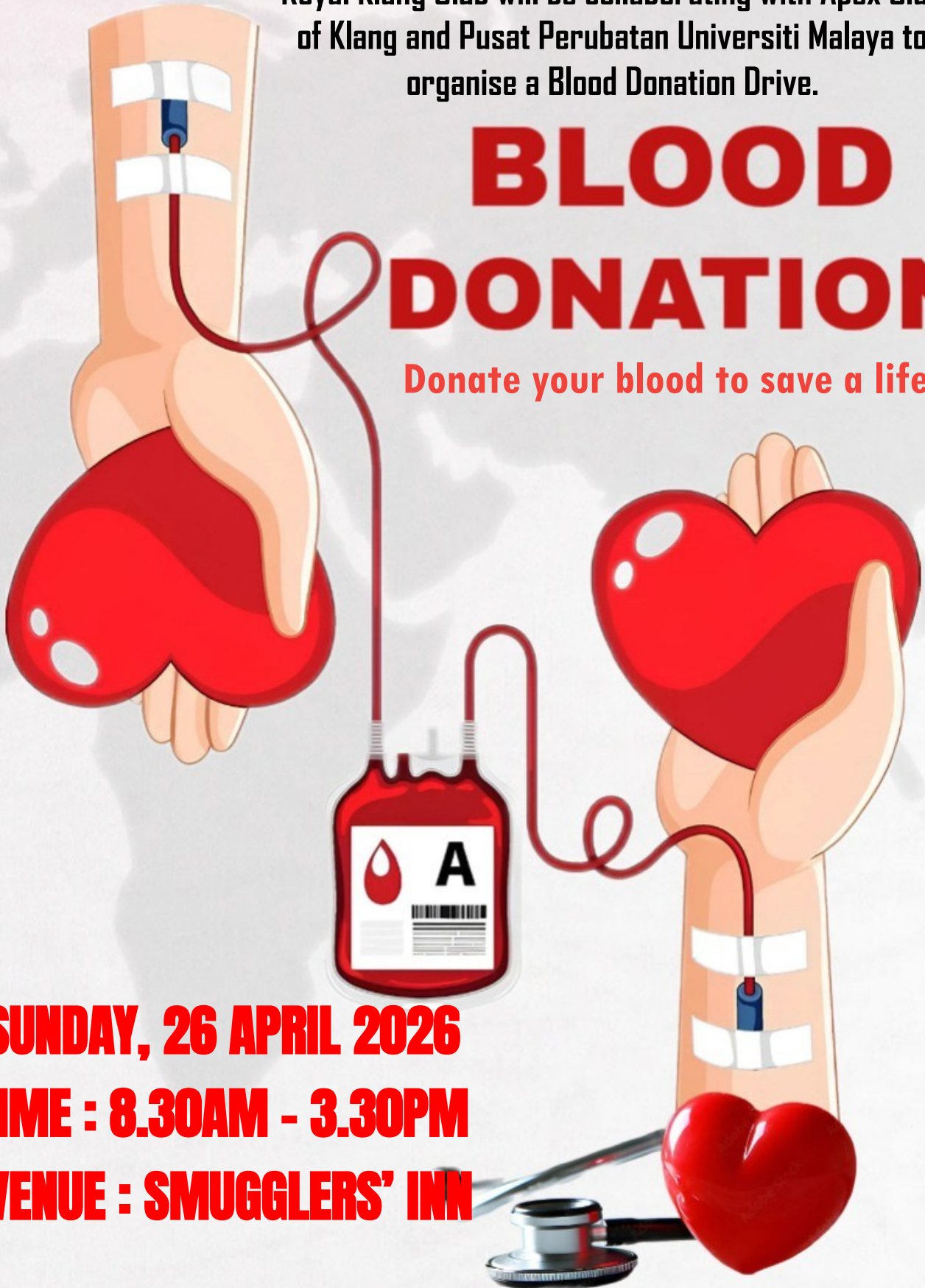
